2nd European Cooperation Neurology Workshop **Třešť, Czech Republic, April 20 – 25, 2001**

In the second course 61 participants from 17 countries took part. For the first time young neurologists from Greece and Italy joined the workshop.

Discussions to practical issues in neurology aimed at international comparisons and to proposals for future standards. The collection of data in the first and in the second course gave material for 2 papers in scientific journals:

The first and the second workshops invoked a new spirit of neurological solidarity, gave rise to new friendships and triggered contemplations about new international links. In the words of Prof Jim Toole who visited the second course as president of the World Federation of Neurology „it was most impressive to be with the young neurologists ... in this ... one of the stellar accomplishments of the ten years old EFNS.“

The cultural program has been performed by a quintet of students from Pardubice conservatorium, works from Bach, Mozart, Britten and Milhaud.
